## WAIVER & RELEASE OF LIABILITY & INDEMNITY AGREEMENT

Upon signing this Agreement and forever thereafter, you agree that if you participate in or attend any FBT or FBT related event, you do so at your own risk and assume the risk of any and all injury and/or damage you might sustain, regardless of whether you are a participant, a spectator, or otherwise. You agree that you are voluntarily participating in the aforementioned activities and assume all risk, known and unknown, associated with same. You agree on behalf of yourself (and your spouse, all your children, personal representatives, heirs, executors, administrators, agents, and assigns) to forever release and discharge FBT members, board members, tournament officials, agents, representatives, affiliates, successors, and assigns from any and all claims or causes of action (known or unknown) arising out of the negligence of FBT, whether active or passive. This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) your use of any equipment or facilities which may malfunction or break; (b) FBT's negligent instruction or supervision; (c) you sustaining personal injuries as a result of the dangerous condition of property on which you are present in relation to any FBT function, including FBT's negligent inspection or maintenance of such premises. By executing this Agreement, you hereby agree to indemnify and hold harmless FBT from any loss, liability, damage, or cost FBT may incur due to your presence at any FBT related event. You further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law of the state in which this agreement is entered into, and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release is not intended as an attempted release of claims of gross negligence or intentional acts.
